Thrift Shop: Nina Jelinek Chair

The month of November, 2023, the Thrift Shop has earned \$36,609 after taxes and before expenses.

- The month December, 2023 the Thrift Shop has earned \$15,042 after taxes and before expenses.
- Year to date revenue is \$199,844.

Annual Fundraiser: Linda Combe Chair

- Year to date revenue before expenses is \$33,929. Total is up from \$26,529 in November. Year to date revenue in the different areas of the Annual Fundraiser:
 - o Boutique sales: \$9,675 (remains the same).
 - o Raffle sales: \$3070 (remains the same as November).
 - o Donations: \$21,184 (up from \$13,834 in November).

Buildings:

- Perry Roofing conducted the annual roof inspection at the end of November, including gutters, drains and valleys. Minor caulking of pipes, vents, and a/c units. No additional issues found.
- Allison Heating and AC did the quarterly replacement of filters on all of our 9 units.
- Owen Electric did maintenance to faulty lighting in Thrift Shop.
- The annual deep cleaning was completed at the end of December.
- All City Plumbing had to install a new pressure valve outside CH in order to repair seals around toilet and urinal in CH men's bathroom.

Grounds:

- Owen Electric conducted outside lighting inspections and replaced them where necessary. I am waiting for prices for new outside lighting fixtures on the west side of CHN and north side of the Thrift Shop
- Secure Tel came when the chain on our electric exit gate came off and corrected the problem.
- The recent rain interfered with sensors on the entry electric gate. I have asked Secure Tel to install a protective cover.
- J.T. Sites has submitted a proposal to address the drainage problem on Chapter House north, allowing water to seep under the door during heavy rains. Will request this be part of the 2024/25 budget.
- Continue to report to RC Community Improvement Office the shopping carts and junk left by transients in the area.
